Based upon soil tests, forage density, soil type and indicator species, the Panama City-Bay County Airport and Industrial District is accepting sealed bids for the following items:

1. 38 tons – 15-0-15 SR Fertilizer (with micronutrients) (no extra iron)
Spread acreage – 500 acres @ various rates/AC as specified by Airport
(Price to include delivery and application)
2. 88 tons – Dolomitic Lime
Spread acreage – 700 acres @ various rates/AC as specified by Airport
(Price to include delivery and application)

Fertilizer delivery dates after April 15th, in coordination with Airport Maintenance Department, pending weather conditions.

Lime application prior to May 15th, in coordination with Airport Maintenance Department, pending weather conditions.

Scheduling can be coordinated and is flexible.

Awarding of the bids will be based on price.

Price to be good for 60 days after bid date.

There is no express or implied obligation for the Panama City-Bay County Airport and Industrial District to reimburse responding firms for any expenses incurred in preparing proposals in response to this request.

The Panama City-Bay County Airport and Industrial District reserves the right to reject any or all bids, to waive any irregularities or informalities in any bid or in the bid procedures, and to accept or reject any item or combination of items.

I understand that “convicted” or “conviction” as defined in Paragraph 287.133(1)(b), Florida Statutes, means a finding of guilt or a conviction of a public entity crime, with or without an adjudication of guilt, in any federal or state trial court of record relating to charges brought by indictment or information after July 1, 1989, as a result of a jury verdict, non-jury trial or entry of a plea of guilty or *nolo contendere*.
4. I understand that “affiliate” as defined in Paragraph 287.133(1)(a), Florida Statutes, means
 - A. A predecessor or successor of a person convicted of a public entity crime; or
 - B. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term “affiliate” includes those officers, directors, executives, partners, shareholders, employees, members and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm’s length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of a public entity crime in Florida during the preceding 36 months shall be considered an affiliate.

I understand that a “person” as defined in Paragraph 287.133(1)(e), Florida Statutes, means any natural person or entity organized under the laws of any state or of the United States with the legal power to enter into a binding contract and which bids or applies to bid on contracts for the provision of goods or services let by a public entity, or which otherwise transacts or applies to transact business with a public entity. The term “person” includes those officers, directors, executives, partners, shareholders, and employees, members, and agents who are active in management of an entity.
