<u>AGREEMENT:</u> Professional Engineering, Architectural, Project Inspection, Construction Management and Planning Services

OWNER: Panama City-Bay County Airport and Industrial District

CONSULTANT: ZHA Inc. and its sub-consultants noted below.

SUBCONSULTANTS: Fitzgerald Collaborative Group (FCG) and MySmartPlans

<u>TASK ORDER DESCRIPTION:</u> North Terminal Concourse Expansion – Bidding & Award and Construction Administration Services

SCOPE OF SERVICES: The CONSULTANT shall provide bidding & award and construction administration services to convert the current shell space on the 2nd floor of the north terminal into hold room space for passenger boarding from that area to ramp loading positions on the north apron area. The design includes the addition of new restrooms, and concession spaces and creation of passenger seating areas and gate boarding podiums and an exterior walkway with ramps and stairs from the 2nd level to the aircraft apron. The design also includes the removal of existing restrooms in the central terminal and addition of floor space to allow for the circulation from the central terminal.

Background: The OWNER has determined that additional passenger hold room space needs to be developed to accommodate new air carriers and increased aircraft size projected for future year's traffic. The North Terminal Concourse expansion has been designed and is ready to be bid and constructed.

The bidding & award and construction administration services will include issuing bid documents for competitive construction bids, conducting pre-bid meetings and site tours, issuing addenda, evaluating the bids received and preparing a recommendation for award to airport board. Upon award of the contract, the CONSULTANT will provide all the required Construction Administration services to manage the project thru its completion and closeout. Generally, this will include participating in regular project meetings, reviewing the progress of the construction, reviewing monthly applications for payment, evaluating any change request, evaluating the progress related to the original construction schedule, provide regular updates to staff and the board and manage the closeout process.

<u>SERVICES NOT INCLUDED:</u> Services do not include of project surveys. If required, these will be addressed in a separate task order.

<u>SCHEDULE OF SERVICES:</u> Services will begin immediately upon authorization. It is anticipated. Bid & Award will take 30-45 days. Construction is estimated to ten months to Substantial Completion with Closeout taking an addition 30 – 45 days. Construction start is subject to funding approval and Notice to Proceed.
